

TERMS AND CONDITIONS OF USE FOR USERS

Idiomas Tec, whose legal nature is 2135 - Entrepreneur (Individual), registered with the CNPJ under N°. 41.750.051/0001-18, headquartered in the State of São Paulo, in the City of São Paulo, at Estrada das Lágrimas, N°. 3.621, São João Clímaco, Zip Code 04244-000, is a legal entity under private law responsible for the Biblical Greek application.

Through these General Terms and Conditions of Use (Terms), Idiomas Tec presents to users (Users) the essential conditions for the use of the services offered in the application.

By using the Biblical Greek application, Users accept and abide by the conditions of these Terms and the Privacy Policies.

1. Definitions

1.1. For the purposes of this document, the following definitions and descriptions should be considered for your better understanding:

Cloud Computing: is a service virtualization technology built from the interconnection of more than one server, through a common information network (example the Internet), in order to reduce costs and increase availability of sustained services.

Access Account: login and password to access the Biblical Greek application and its functionalities, created through personal information provided by the User.

Content: any and all text, graphics, images, music, audio, video, information or other materials made available in the app, regardless of whether it is User Content, Partner Content, or Biblical Greek App Content.

Content of the Biblical Greek application: any and all content that Idiomas Tec makes available through the Biblical Greek application, including any content licensed from third parties, but excluding User Content.

User Content: any and all content that a User posts, transfers, publishes, presents or transmits to be made available in the app stores where the Biblical Greek app is marketed.

Link: terminology for Internet address.

Platform: mobile app stores for downloading and installing the Biblical Greek app.

Services: refers to any and all services provided by Idiomas Tec through the Platform.

Payment System: system used by Idiomas Tec in partnership with the Platform that provides download, installation and subscription of the Biblical Greek application, enabling the contracting and payment of the plans offered through the Platform. The interested User must register their credit card data on the Platform in order to use this service.

User: natural person, fully capable in accordance with the Civil Law, able to contract the Services offered through the Platform.

2. Object

2.1. The services covered by these Terms consist of:

2.2. Biblical Greek is a Greek language teaching application used in writing the Septuagint (first translation of the Old Testament into Greek) and in writing New Testament texts. Biblical Greek was created to help theology students and Christians interested in reading and understanding biblical texts in Koine Greek (Hellenistic Greek), also known as the popular form of Greek that emerged in post-Classical Antiquity.

2.3. Biblical Greek activities can be accessed on the mobile app available on the Platforms.

2.4. Idiomas Tec is exclusively responsible for the veracity and accuracy of the content of its Services advertised on the Platform.

2.5. All payment and transfer of amounts must be made exclusively by the means provided by the download, installation and subscription platforms for the Biblical Greek application.

2.6. When registering, the User has access to some free activities available on the Platform and, to have access to all activities, he/she needs to subscribe to one of the plans offered in the Biblical Greek application - monthly, semi-annual and annual, declaring, therefore, to have read, understood and accepted the Terms.

3. Registration

3.1. Anyone can register and perform the free activities available on the Platform. However, to access paid activities, that is, those available only to subscribers, the User must follow the paid subscription guidelines available on the Platform.

3.2. Registration can be carried out directly on the Platform, by filling in the personal data requested by Idiomas Tec.

3.3. Idiomas Tec reserves the right to refuse any registration request and to cancel a previously accepted registration, at its sole discretion and without prior notice, with no indemnity or reparation for cancellation of any registration or impossibility of registration.

3.4. By creating an account in Biblical Greek, the User is responsible and obligated to provide only true, accurate and authentic information and to keep them updated while using the Biblical Greek application. Users of Biblical Greek guarantee and respond, in any case, civilly and/or criminally, for the veracity, accuracy and authenticity of the registered Personal Data.

3.5. Idiomas Tec is not responsible for the veracity, accuracy, authenticity or updating of User data.

3.6. The User undertakes to notify Idiomas Tec, through the contact channels maintained by Biblical Greek on the Platform, of any suspicion or finding of unauthorized use of their account. The User will be exclusively responsible for the operations carried out on his account, since access will only be possible through the use of a verification system that is exclusive to his account.

3.7. Under no circumstances will the assignment, sale, rent or other transfer of the account be permitted. The creation of new registrations by people whose original registrations have been canceled due to breaches of Idiomas Tec's policies will not be allowed.

4. Payment Methods

4.1. Payment of subscriptions, for access to paid activities, will be made by Credit Card through the Platform (Virtual Stores).

4.1.2. When choosing one of the types of subscription – monthly, semi-annual or annual, the User must be aware that the renewal of his/her subscription is automatic. The User may, at any time, cancel his/her subscription. In order to avoid future recurring charges, it is the User's sole duty to cancel early enough so that the amounts are not posted on his/her credit card statement.

4.2. Subscription types and payment method are available on the Platform.

5. Discounts and Promotions

5.1. Idiomas Tec may, at its free and exclusive discretion, offer discounts to its Users. By accepting these Terms, Users are aware that discounts and/or promotions:

- a)** they may be limited to a certain number of Users or to a specific period, to be previously informed by Idiomas Tec;
- b)** they can only be used through the Biblical Greek application and via credit card payment;
- c)** they will have defined rules to be made available on the Platform and/or other communication channels between User and Idiomas Tec.

5.2. Users will not be refunded in cash and/or will not be entitled to other discounts and/or promotions if:

- a)** at the time of purchase of the discount and/or promotion, the User is pointed out that the limit on the number of users or specific period of discount and/or promotion has been exceeded;
- b)** there is any problem, which is not the sole fault of Idiomas Tec, at the time of payment;
- c)** any systemic problems occur and/or with the respective credit card company, the fault of which is not exclusive to Idiomas Tec.

6. User Responsibilities

6.1. The User is responsible and undertakes to:

- a)** acknowledge that all accesses made to the Biblical Greek application are interpreted as having been made by him in an incontestable manner, and any form of login and password sharing for outsiders' access to the application's content is prohibited;
- b)** have technological devices, resources and equipment with antivirus and firewall enabled, software duly updated, in addition to adopting minimum security measures for accessing the Biblical Greek application.

6.2. The functionalities of the Biblical Greek application are offered in the form of service provision, not granting the User any right to the software or to the information technology structures that support it.

7. Service Cancellation Policy

7.1. The User who wishes may request the cancellation of his/her subscription contracted directly by the Platform, with sufficient notice so that the values are not included in future invoices.

8. User Subscription Cancellation Policy

8.1. Idiomas Tec may terminate these Terms, User Accounts or Users' access to the Biblical Greek application at any time, without prior notice or consent and in its sole discretion. The User may cancel his/her subscription to Biblical Greek on the Platform himself/herself, as long as it has no outstanding obligations in relation to Idiomas Tec.

9. Disclaimers and Limitations of Liability of Idiomas Tec

9.1. Idiomas Tec respects and obeys all laws and regulations applicable to its activities and expects all its Users to do the same. However, Idiomas Tec cannot guarantee and assumes no responsibility for the compliance of its Users with any laws or regulations. By using the Biblical Greek application, the User declares to be aware, understand and agree that he/she is the sole and fully responsible person for complying with any and all laws, rules, regulations and legal and tax obligations that may apply to the use of the Biblical Greek application.

9.2. Users acknowledge and agree that:

a) Idiomas Tec will not be responsible for errors and/or inconsistencies in the provision of information when the User is registering himself/herself in the Biblical Greek application;

b) Idiomas Tec does not directly manage the payments made by its Users and does not store their bank or credit card details, using, for greater security, services offered by the Platform on which the Biblical Greek application is made available. Idiomas Tec does not assume any responsibility for errors, setbacks or damages arising from the use of these services, including, but not limited to, loss of values, excess charges, delays in payment confirmation or disclosure of data on the use of these services, registration, banking or secrets provided during transactions;

c) Idiomas Tec is not responsible for fraud, nor for any damage caused by the action of third-party counterfeiters who, by shady means, steal the Users' bank details and/or credit card data or any other form of payment. It is also not responsible for viruses, trojans, malware or any other malicious program installed on the User's computer, tablet, cell phone, mobile device or browser in order to obtain User's bank and/or credit card data or any other form of payment ;

d) Payments made by Users may be canceled at any time by the credit card operator or financial institution, and the cause of said cancellation will not be disclosed by Idiomas Tec, for reasons of bank secrecy. For these cases, Users must, if they deem it necessary, contact the financial institution and/or credit card operator that has a legal relationship;

e) Idiomas Tec will not be liable for any damages or losses caused to your cell phone(s), computer(s) or any other electronic equipment, as a result of accessing and using the Platform;

f) Idiomas Tec is not responsible for any damage, loss and/or loss suffered by the User due to failures in their internet connection, with their provider, in the operating system or server used by the User, resulting from the conduct of third parties , Act of God or force majeure;

g) Idiomas Tec will not be responsible for any virus, trojan, malware, spyware or any software that may damage, change the settings or infiltrate the User's equipment as a result of accessing, using or browsing the internet, or even as a consequence of the transfer of any data and information.

10. Intellectual Property

10.1. The commercial use of the expression "Biblical Greek" as a trademark, business name or domain name, as well as the logos, brands, insignia, layout of Biblical Greek, screen content relating to teaching activities in Biblical Greek are the property of Idiomas Tec and are protected by copyright, trademark, patent, model and industrial design laws and international treaties. Misuse and total or partial reproduction of the aforementioned contents are prohibited, unless expressly authorized by Idiomas Tec.

10.2. Any intrusion, attempt, or activity that violates or contravenes intellectual property law and/or the prohibitions stipulated in these Terms of Use will make the person liable for the relevant legal actions, as well as the sanctions provided for herein, being also responsible for indemnities for any damage caused.

11. Prohibitions

11.1. Any attempt, direct or indirect, successful or not, to carry out any of the activities listed below is prohibited. The verification of such intent will make the author, as well as his principals, defenders, encouragers and helpers, subject to the sanctions provided for in these Terms, the relevant legal actions and the responsibility to indemnify any affected parties for any damage caused. Such activities include, but are not limited to:

a) Annoying, assaulting, slandering, insulting, defaming, stalking or harassing any other User of Biblical Greek;

b) Infringe the rights of any person or entity, including, without limitation, intellectual property, privacy, publicity or contractual rights;

- c) Copy, store, or otherwise access any information contained in the Platform or Services or Content for purposes that are not expressly authorized by these Terms;
- d) Use the Platform or Services to transmit, distribute, publish or send any information relating to any other person or entity, including, without limitation, photographs of other persons without their permission, personal or credit contact information, telephone number or numbers of bills;
- e) Manipulate the values of the Services or any other information contained in advertisements, on the Platform or Services;
- f) Use the Platform or Services for any commercial or other purposes that are not expressly authorized by these Terms;
- g) Use manual or automated software, devices, robot scripts, or other means or processes to access, "scrape", "crawl" or "spider" any part of the Biblical Greek Content or Services;
- h) Modify, copy, distribute, transmit, display, perform, reproduce, publish, license, create derivative works, display on another webpage, use on any other website, transfer or sell any information, software, user lists, database or other listings, products or services provided by or obtained by Biblical Greek, including, but not limited to, practices involving "screen scraping", "database scraping", or any other activity for the purpose of obtaining user lists or other information;
- i) Use automated scripts to collect information or otherwise interact with the Biblical Greek Platform or Services;
- j) Access, test, tamper with, interfere with or damage the Platform or any system of Biblical Greek or Users through the use of viruses, cancel bots, Trojans, harmful codes, flood pings, denial of service attacks, packaging or spoofing IP, forged routing or electronic address information or similar methods or technology;
- k) Attempt to detect, scan, or test the vulnerability of any Biblical Greek system or network or violate any security or authentication measures;
- l) Forge any TCP/IP header packet or any part of the header information in any publication, email or newsgroup, or otherwise use Biblical Greek Content or Services to send altered, misleading or false source identification information;
- m) Attempting to decipher, decompile, disassemble or reverse engineer Biblical Greek Services or Content.

12. Sanctions

12.1. If any User does not comply with any provision of these Terms and other Policies of Idiomias Tec or does anything that harms the Platform, the Biblical Greek application or the Users, Idiomias Tec may, in its sole discretion, at any time and without notice or consent previous:

- a) Permanently suspend or terminate the User's Account and any and all access by such User to Biblical Greek Content and Services.
- b) Take appropriate action to investigate and judge violations of any nature to the fullest extent of the law, and may involve or cooperate with judicial and police authorities.

13. Governing Law and Jurisdiction

13.1. All items of these Terms are governed by the laws in force in the Federative Republic of Brazil. For all matters relating to the interpretation, compliance or any other question related to these Terms, the parties agree to submit to the Judicial District Court of São Paulo.
